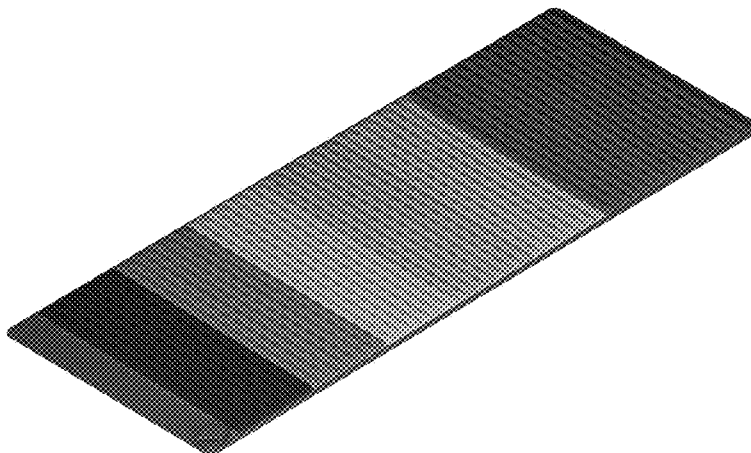
The ornamental design for a mat, as shown and described.

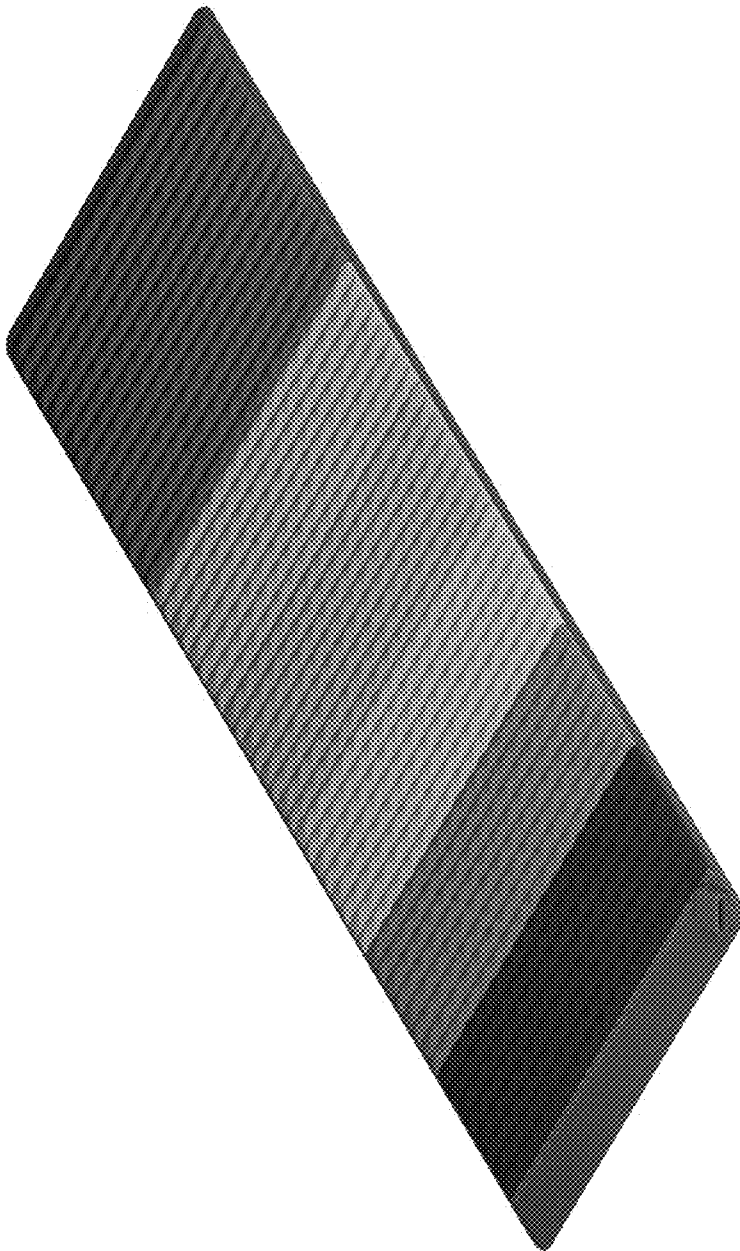

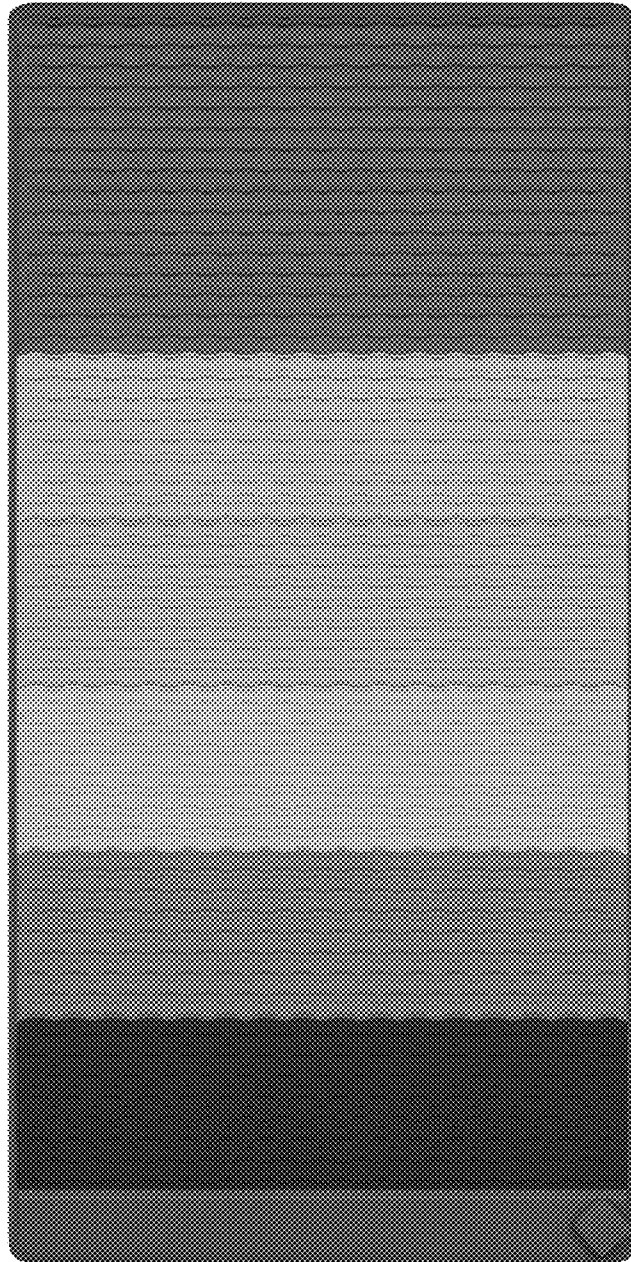

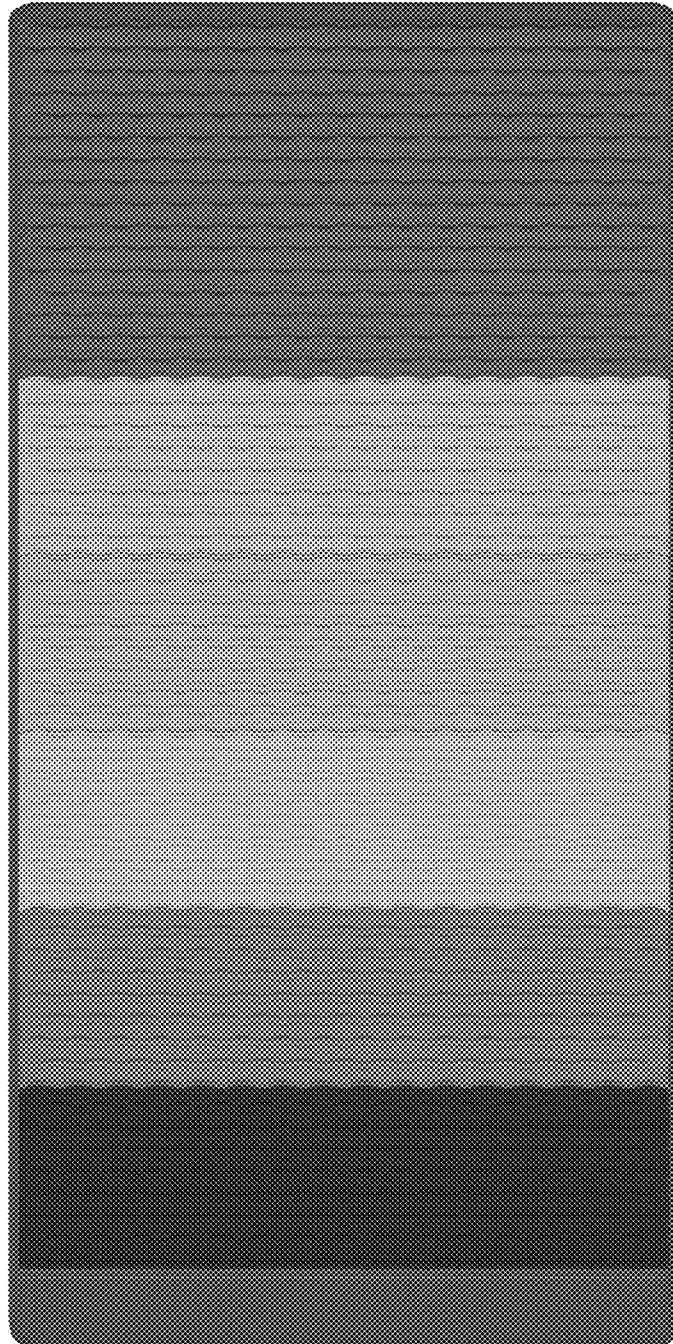

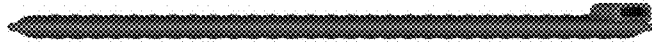
